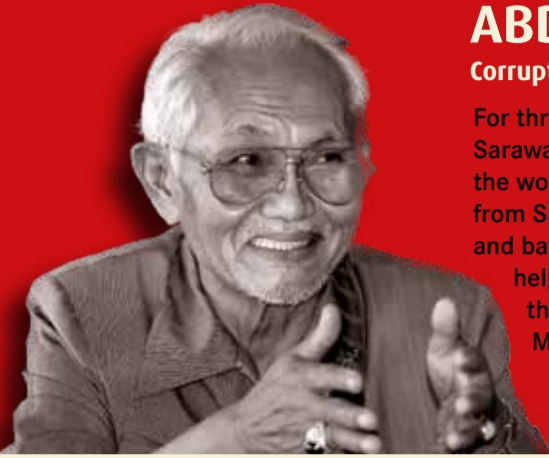


TAIB'S FOREIGN HELPERS
